## Notice of Public Meeting Concerning Official Plan Amendment and Community Improvement Plan Expansion

#### File No. OPA-02-22 and CIP-E

**Take Notice** that pursuant to Section 17(15) and Section 28(2) and (4) of the Planning Act R.S.O. 1990, as amended, the Township of Cavan Monaghan will hold a Public Meeting to consider a proposed amendment to the Township of Cavan Monaghan Official Plan and to consider an expansion to the Millbrook Community Improvement Plan (MCIP).

Official Plan Amendment No. 11 to the Township of Cavan Monaghan Official Plan has been initiated by the Township to expand the existing Community Improvement Plan (CIP) area to include all lands within the Township. The proposed Amendment will identify two (2) new CIP areas – Urban Fringe Area and the Rural Area and add several new objectives to the CIP policies in the Plan.

The proposed OPA applies to all lands within the Township of Cavan Monaghan. As such, no key map is provided.

A CIP establishes a planning and economic development framework designed to stimulate private sector investment to meet community improvement goals and objectives. The CIP-E is intended to be used in tandem with the MCIP. The amended CIP-E policies will support community development across the Township by providing a framework for funding opportunities and programs available to businesses, property owners and tenants in each of the three (3) identified areas.
