



**Notice of Complete Application and Public Meeting  
Proposed Zoning By-law Amendment**

**County Road 10  
Part of Lot 13, Concession 14 (Cavan)  
Township of Cavan Monaghan**

**File No. ZBA-04-23**

In accordance with the provisions of the Planning Act, as amended, this Notice is to advise that the Township of Cavan Monaghan Planning Department received a complete application for a Zoning By-law Amendment. The Application applies to lands located in part of Lot 13, Concession 14 (Cavan) and identified by property assessment roll number 1509-010-050-185-00.

The Zoning By-law Amendment is required to permit the construction of a single detached dwelling and associated accessory buildings on each of three (3) new lots created by severance. The file numbers associated with the Peterborough County severance applications are B-93-21, B-94-21 and B-95-21.

The Zoning By-law Amendment application was received by the Township on July 20, 2023 and deemed complete on August 4, 2023.

**Subject Lands**

A key map showing the location of the property is provided on Page 4.

The lands subject to the Zoning By-law Amendment are approximately 36.8 hectares (91 acres) in size with approximately 1293 metres (4241 feet) of frontage on County Road 10, approximately 222.5 metres (728 feet) of frontage on Hayes Line and approximately 119 metres (390 feet) of frontage on Mount Pleasant Road. The property is currently developed with a shop used to support the agriculture use on the property.

## **Purpose and Effect of Zoning By-law Amendment Application**

The lands subject to the Application are currently zoned the Future Residential (FD) Zone, the Agricultural (A) Zone, the Natural Core (NC) Zone and the Natural Linkage (NL) Zone on Map A-3 to By-law No. 2018-58, as amended.

The first purpose of the Zoning By-law Amendment is to rezone a portion of the subject lands from the Future Residential (FD) Zone and the Agricultural (A) Zone to the Hamlet Residential (HR) Zone to permit the construction of a new single detached dwelling and a maximum of three (3) accessory buildings on each of the new lots created by consent (severance). The second purpose of the Zoning By-law Amendment is to rezone a portion of the subject lands from the Agricultural (A) Zone to the Agricultural Exception Twenty (A-20) Zone to recognize the lot area of the retained lot in the Agricultural (A). The portion of the property currently zoned the Natural Core (NC) and Natural Linkage (NL) Zones will remain unchanged.

### **Right to Appeal**

If a person or public body does not make oral submissions at a public meeting or make written submissions to the Township of Cavan Monaghan in respect of the Zoning By-law Amendment before Council approves or refuses to approve the Amendment, the person or public body is not entitled to appeal the decision of the Township to the Ontario Land Tribunal.

If a person or public body does not make oral submissions at a public meeting or make written submissions to the Township of Cavan Monaghan before the Council approves or refuses to approve the Amendment, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.
