The Municipal Drinking Water Licence and the Permit to Take Water permits a maximum water taking rate at the well house of 3,000 m³ day; and a peak flow rate of 1,500 L/minute. PUG Services Corp. aims to adhere to the operational and compliance limits set out in the Permit and Licence however, certain operational circumstances may cause results to be temporarily outside of the limits. In the months of July and September, operational staff performed valve maintenance and winterizations activities, that resulted in a slight increase of peak flow over the allowable limit. This is acceptable as per paragraph 3.4 of the Permit to Take Water 7704-AW7HJF.
