

2023 Final Tax Bill Newsletter

Residential Property Tax Rate Increase (3.62%)

For 2023, the total combined property tax increase is 3.62%. The combined rate includes a 3.62% increase from the Township, a 5.14% increase from the County, and no increase to the education rate from the Province.

These tax rates are set by the Township, the County of Peterborough and the Province of Ontario. The rates are then applied to your property's Current Valued Assessment (CVA) which is established by the Municipal Property Assessment Corporation (MPAC) and can change upon reassessment or changes to your property. For example, in 2023 for every \$100,000 of Current Value Assessment (Residential) of your property, you will pay \$1,293.15 of property tax. A full list of 2023 tax rates is on the website:



Collecting Taxes

The Township of Cavan Monaghan is responsible for collecting the property tax for the Township, the County and the School Boards. The Municipal portion of the property taxes pays for a wide array of services including garbage collections, winter snow removal, road repair and maintenance, parks and recreation, library services, animal control and economic development to name a few. The County portion of property taxes goes toward maintaining County roads, bridges and culverts, paramedic services, social services, recycling collection, landfill operation and other services provided throughout the County of Peterborough. Applications must be received before November 15, 2023

There are three components to your final tax bill:

Municipal (58%), County (30%) and Education (12%). Annually property owners receive an Interim Tax bill (January) and a Final Tax bill (July) for property taxes.
