

## Township of Cavan Monaghan Notice of Passing of Development Charges By-law

**Take Notice** that the Council of the Township of Cavan Monaghan passed development charges By-law No. 2022-43 on the 2nd day of August, 2022 under section 2 (1) of the Development Charges Act, 1997, S.O., 1997 c. 27, as amended;

**And Take Notice** that that any person or organization may appeal to the Ontario Land Tribunal under section 14 of the Act, in respect of the development charges by-law, by filing with the Clerk of the Township of Cavan Monaghan on or before the 13<sup>th</sup> day of September, 2022 a notice of appeal setting out the objection to the by-law and the reasons supporting the objection.
